Parks are Taking Emergency Planning Steps

Milton Mobile Home Cooperative and the Bunker Hill Community Cooperative in Windsor are both working with the Mobile Home Program to create park emergency planning committees and park emergency plans. The park emergency planning committees have created a park communication plan and identified potential hazards in their communities. In the event of any emergency, a power outage, fuel spill or flooding, these groups will know what resources they have, which households might need special assistance, and have a contact list ready for places they may need to call for information. Planning in advance gives communities the chance to talk through "what would we do if..." in advance in a relaxed setting and not in the middle of a crisis. This winter, staff from Vermont Department of Emergency Management and Homeland Security will be working with the Milton Cooperative to practice their emergency plan. Planning for emergencies is always a great idea, especially having a family communication plan and three days of supplies on hand. 2014 Threshold for Rent Increase Mediations

In 2014, park residents may request mediation for **any rent increase above 3.2%.** Here's how it works:

- 1. Notices of rent increase must be given 60 days in advance on an official form from the Department of Economic, Housing, and Community Development (DEHCD).
- 2. The form gives the amount of rent increase in dollars and as a percentage.
- 3. If the percentage is greater than 3.2%, you may request mediation.
- 4. To request mediation, you must gather the signatures of a majority of the homeowners in the park within 15 business days. Call the Mobile Home Project for a petition form.
- 5. The state will pay for a professional mediator to sit down with a representative for the residents and a representative for the park owner. Many mediations results in a smaller rent increase.

The annual threshold is determined by adding 1% to the annual change in the Consumer Price Index (CPI) Housing portion.

Fuel Tank Safety Tips

There is never a bad season to think about fuel tank safety. This season, take a few minutes to run through this short safety checklist. If you answer yes to any of the following questions contact your licensed oil heat technician for an inspection and to correct problems. If you find a spill, don't delay; report the spill to Agency of Natural Resources Waste Management Division.

1) Are the tank legs unstable or on an uneven

5) Are there any threats of snow or ice falling on the oil tank or filter? (The two main causes of spills come from copper lines leaking under a concrete floor slab and from falling snow and ice damaging fuel filters and outside lines.) □ No □ Yes	<u> </u>
6) Are there any signs of the tank's vent being clogged or blocked by ice or snow? (Screened vents are available to prevent insect nest problems.) □ No □ Yes	
7) Is the overfill whistle obstructed, or silent when the tank is being filled? (It should whistle.) □ No □ Yes	
8) Are there any signs of spills around the fill pipe? □ No □ Yes	
9) Is the tank's gauge cracked, stuck, or frozen? Do you see oil staining around it? □ No □ Yes	
10) Is your tank more than 25 years old? □ No □ Yes	
11) Is your outside tank a dark color? (It should be painted a light color to minimize corrosive condensation inside the tank.) □ No □ Yes

Help for Mobile Home Down Payments

It just got a little easier to buy a mobile home. The Champlain Housing Trust will finance 20% to 50% of your home's purchase price, and you do not have to repay the loan until you sell the home. Thanks to state funding, you pay no interest. Here are the details: The home must be Energy Star rated, 1997 or newer. You must be able to get financing from another source for the remaining purchase costs. You must also be able to pay for 5% of the purchase costs from you own pocket (unless you are a Tropical Storm Irene survivor).

The new loan product was created to increase homeownership, promote energy efficiency, and help Irene survivors buy new homes. However, you do not have to be an Irene survivor to be eligible, and you can live anywhere in Vermont.
